

# Improving end of life care in care homes

## Methods

Following the 9 month training programme care homes proceed to GSFCH Accreditation, which includes:

- Audit use of the online After Death Analysis
  (ADA) Audit Tool for 5 patient deaths before and after training and at accreditation.
- Self assessment check list of 20 quality standards that have been taught throughout the training programme.
- Portfolio Compilation of a detailed portfolio providing evidence of achievement of all 20 standards.
- A visit by an independent objective GSF assessor to assess the more qualitative aspects of care including consistency of

# **Key Messages**

- GSF in Care Homes—a validated training and accreditation process to quality assurance and quality recognition to ensure best practice for all care home residents.
- Nationally recognised as a marker of excellence by national policy ,commissioners and the public
- Since 2004, about 500-800 homes/year have been trained, up to 200 homes accredited/year plus 3 yearly re-accreditation of homes
- Rigorous validated accredited process awarded excellence by National Skills Academy (NSA)
- GSF Accreditation now forms part of the assessment by the national regulator (Care Quality Commission-CQC) and information available to the public to support choice of care homes

# Results

About 400 homes have undertaken GSF care homes accreditation process . The accredited homes have been included on a publicly available database and are known as centres of excellence helping to develop a national momentum of best practice .



#### 1) Improved quality of care

More proactive planning + averted crises

#### Increased prescribing consistency with GPs

Earlier discussions with families with advance care planning led to easier care in the final stage.

#### 2) **Example of potential cost savings**

Decreased crisis hospital admissions approx  $(^{1}/_{3})$  & Decreased hospital deaths approx  $(^{1}/_{2})$  equating to estimated savings of **about £40-80,000** care home/ year
